Class Title: HAZ-MAT Incident Commander “IC” (16+ HOURS)

Dates: February 21 and 22, 2012

Class Description:

This CSTI certified course is designed to provide the tools a responder needs to assume control of an emergency response to a hazardous materials incident. It focuses on legal and practical requirements to safely and competently manage a hazardous materials incident. Completing this course exceeds the training requirements of state and federal OSHA HAZWOPER regulations.

Course topics include:

- Laws, Regulations & Legal Liability
- Hazard Assessment
- Team Typing
- Protective Actions
- Haz Mat Site Safety
- Operational Risk Management
- Incident Termination
- Pipeline Incidents
- Local Team, Haz Mat Plan & SOG Use
- Advance Decon Operations and Certified Decon Package (CERFP)
- Civil Support Team Activation & Use

Upon completion, you will receive a CSTI certificate that will be issued 8-12 weeks after the class. This course is sponsored by SLO County Fire Training Officers, and SLO County Fire Department.
